### **12. Confirmation of the Minutes of 22.04.2025**

c. Defibrillator Cwmdud -. Cheque received through the hand of Cllr. Eifion Jones in the sum of £662.72 has been paid into the Defibrillator Account.

Clerk is to write to Mrs Joyce Bowen, Mr Peter Watson and Mr Geoff Goodbourn to acknowledge receipt and give thanks on behalf of the Council.

The Council decided that the Clerk and Chair. are to make enquiries in order to purchase the most suitable/compatible model of defibrillator for Cwmdud. The Council will pay the shortfall. The funds in the defibrillator account as at 30.4.25, excluding the £662.52 received = £1,533.23. There are 3 sets of electrode pads to be replaced by the end of June at a cost of £162. The Council decided that provision is made when calculating the budget each year for the purchase of defibrillator consumables.

Cai Phillips proposed a motion in September 2024 after the Council identified that there was a problem locally where the original Welsh names of properties had been changed without consultation-following further discussion regarding the wording of the motion Cllr. Delme Phillips proposed that the revised motion is submitted

#### **"MOTIONS FOR 2025 ANNUAL GENERAL MEETING ONE VOICE WALES**

The conference notes that there is a dire problem with the changing of indigenous Welsh house names to English across Wales. Welsh names are an important part of our cultural identity and our history.

The conference calls on the Welsh Government to introduce a law in order to protect Welsh names. This should include statutory consultation for Community and Town Councils before the name of a house changes.

The conference calls on County Councils to introduce a similar scheme to Ceredigion County Council where a package is delivered to a house owner to "encourage and reconsider" before changing the name of the house from Welsh to English or any other language"

This was seconded by Cllr. Bryan Davies. Cllr. BD agreed to attend the AGM in October and to address the conference on behalf of the Council regarding the proposed motion if invited to do so.
