57.Highway Matters:

Highway Matters reported on: 22.09.2025

Cllr. E.D. proposed that the clerk writes to thank the County Council for all works carried out to date throughout the Cynwyl Elfed area and especially on the A484 between Cynwyl Elfed and Hermon where clear warning signs are now in place that the road narrows.

a)Pothole in the road outside Villa, Blaenycloed.

b) Penlanchwilor - Blocked drain SA33 6UD

c) Rhiw Clos y Graig - overgrown hedges impinging on the main road with branches reaching into the road. Hazard. The Community Council does not know who owns the property.

d) A484- SA33 6UJ - Tree fallen near Esgair last weekend, the tree has been cut but there still remain trees which are a hazard and need to be cleared. Fence broken.

e) C2023 from Cynwyl to Penrhiwcrynfryn - about 1 foot of the road has eroded away.

f) Penrhiwcrynfryn Junction - slip road - road surface has completely eroded.

f) Esgair Junction - Culvert has collapsed again. SA33 6UL.

g) Esgair Layby - Needs to be cleaned.

h) A lower speed limit is required through Esgair.

j)The road from Esgair to Calcit - The side of the road has eroded leaving a sharp edge and a deep drop on the left side of the road.

j) Esgair - Penfoel - Cones have been put in places where the road has run into the gutter - repairs are required.

k) C1294 -The Road to Cwm Hagar - There is a huge split in the middle of the road.

L) Gritting - clerk to contact the County Council to grit C roads - between Penfforddnewydd to Tŷ-Coch, which is a very busy road. And also to ensure that all gritting boxes in the area are re-filled before any frosty weather.

m). A484 at SA33 6AR - tipping of material/debris on land adjacent to the main road - The Council has been told that this matter is being dealt with by the County Council.

n) SA33 6UN - Rhiw Panne - road is in very poor condition and build up of leaves is causing the road to be slippery - road cleaner required.

o)B4299-Maudsland junction to Bryn Moriah- lack of cats eyes.

p) C1313 - it has been reported that debris is building up on the pavement between Cynwyl Elfed and the Vicerage.

q)C2043 - Concerns raised regarding the section of road where a lorry recently came off the road.
